Spiritual Advisor's Message

Message to CWL members of Ontario

I wish to bring greetings to the Catholic women gathered “virtually” for the 74th Annual Meeting of Members of the Ontario Provincial Council. On the eve of a breakthrough from this pandemic, many look forward to regaining their “normal” lives again and be able to gather in person for all kinds of events. But for the time being, I support the decision of the executive to run this year’s convention in a virtual mode, for most part of it to keep everyone safe. This has required great sacrifice and relentless hours of planning and re-planning. It is my sincerest hope that you will all enjoy the efforts, hard work and resilience of the team that put this convention together.

As a new comer to the Archdiocese of Ottawa-Cornwall, I am not a stranger to the region nor to the CWL. I was first introduced to the league in Manitoba where I discovered first hand as a pastor the many services the members of the CWL provided to their respective parishes and to their community. As a bishop in Ontario for the past 8.5 years, I have come to realize the greater role the diocesan and provincial councils play in the life of the Church. You are great thinkers, movers and shakers! You bring to life the Gospel invitation to be the “salt of the earth and the light of the world”. May the Holy Spirit guide your words and actions as you transform our secular world into the Kingdom of God. I believe we still have a little bit of work to do!

Inform the Membership of the League's Position on Current Issues and Priorities and New Programs

Highlights from national meetings, directives, research, media and CWL websites were used to inform members.

The following national priorities were introduced, discussed and acted upon:

- One hundred thirty-six trees were planted to commemorate the 100th anniversary of The Catholic Women's League of Canada.
- Strategic planning workshops at diocesan meetings both in-person and virtual.
- Many councils celebrated 12 Hours of Prayer for Palliative Care.
- Letters were sent to the Prime minister and their members of parliament re current bills such as Medical Assistance in Dying (MAiD).

The following provincial priorities were introduced, discussed and acted upon:

- Continued focus on the provincial theme of "Loneliness."
- Continued work on Loneliness through outreach by phone and visits.
- Letters of protest were sent to the premier and members of provincial parliament urging reform in several areas such as long-term care homes.
- Resolution workshop was shared and facilitated with provincial counterparts.

Foster Open Communication

- Discussed council business with spiritual advisor by phone and at meetings.
- Shared issues from the Assembly of Catholic Bishops of Ontario (ACBO).

Communications from the Ontario Provincial Council were fostered through:

- the *ON-Line Newsletter*, website and Facebook page
- oral reports at executive meetings
- directives from provincial officers to counterparts
- actual and virtual executive and committee meetings
- Constitution & Bylaws, national and provincial policy and procedure manuals, Roberts Rules of Order, national directives
- knowledge gained from attendance at national meetings

Preside at All Meetings of the Council

- Presided at all executive and administration committee.
- Followed advice of national council and cancelled convention during pandemic.

Be a Signing Officer for All Official Documents

- Worked with the provincial treasurer and recording secretary (when needed) to review claim forms and sign cheques and the annual financial statement.
- Letters, cards, certificates, invitations, emails were sent personally and by the administrative assistant on my behalf.

Initiate Policy, in Consultation with the Officers

- Provincial manuals (policy and procedure, convention guide and provincial guidelines) continued to be updated as "living documents".
- Provincial executive members were encouraged to visit the national and provincial CWL websites to glean information especially on Website Wednesdays.

- Directives submitted by every executive member were shared via email with all other executive members and posted on the website.

Be an Advisory Member of Committees

Was a member of the following committees:

- Administration, Guideline & Policy Review, Social Justice Committee, Resolutions

Be the Official Spokesperson for the Council

- Represented the province at the national table.
- Attended meeting with ACBO executive virtually in December with President-Elect Linda Squarzolo to bring the provincial bishops up to date on current CWL activity and offer support to suggested projects.
- Sent virtual greetings for special anniversaries, award ceremonies, as requested.
- Signed council letters to government officials re resolutions.

Appoint Committees

All appointed committees remained in place for the duration of the term of office:

- administration committee
- policy, guidelines, and convention guide review committee
- registration and credential committee
- resolutions review, reading, government visitation and archiving committees
- minutes review committee
- Bishop Bernard F. Pappin bursary committee
- social justice committee
- nominations and elections committee
- annual report book committee

President's Activities Report

- Attended national executive meetings as required and gave written and oral reports.
- Worked with administrative assistant to send letters for a variety of reasons (congratulatory, sympathy, information, etc.).
- Prepared monthly submissions to *ON-Line Newsletter*.
- Participated in the many webinars and retreats offered at national and diocesan levels.
- Worked with convention site to negotiate compromise when plans changed due to the pandemic.
- Negotiated with future keynote speakers about loneliness.
- Other meetings as listed in other categories.

Recommendations

- That new executives hold a mentoring session soon after election, with their previous counterparts, to swap materials and glean ideas.
- That officers save files to flash drives for ease of access and to decrease the amount of paper transferred and stored.
- That presidents keep a running list of activities for their future counterpart.
- That councils and committees take advantage of opportunities to meet virtually, for any reason, to feel connected.

Spiritual Development Standing Committee Report 2020

Spiritual Growth of Members

- The theme "Care for our Common Home", remained the theme for prayer services. Majority of the councils reported they honoured the theme by organizing reflections, planting trees, studying/quoting/referencing *Laudato Si*, encouraging reduction of disposables at meetings and at home.
- With the pandemic restrictions it was a bit harder to incorporate one third of their meeting for spiritual aspects.
- Many councils encouraged their members to take part in virtual retreats, adorations, Stations of the Cross, Divine Mercy Chaplets, novenas, rosaries, remembrance services for deceased sisters, crowning of Mary and litany prayer services to complement further spiritual growth. When permitted, they also did so in person.
- Members watched the CWL Summer Speaker series and spiritual retreat, Women in Mission.
- With much creativity and the use of the internet all dioceses were instrumental in keeping the Spirit alive.
- Spiritual development chairs collected, prepared and presented spiritual bouquets to spiritual advisors and bishops.
- Members arranged / participated in 12 Hours of Prayer for Palliative Care.
- Members celebrated deceased members with prayer services and masses.

Study of Catholic Teachings

- Many different materials and websites listed as aids. To name a few topics studied: *Twelve Strong Women of God, Explaining the Faith, Unique Role of Women as Caregivers, Women as Leaders, The Saints, The Catechism of The Catholic Church, Women at the Well, Inspirational Women's Series* and the article by Shari Guinta, "The Genius of Women".

Role of Women in the Church

- Members served as school trustees.
- Some served on parish pastoral councils and diocesan and/or parish finance, liturgy, screening and diaconate committees.
- The majority of our members held leadership roles in their parish.

Evangelization and Mission Assistance

- Catholic Missions In Canada, is reported to be supported by all dioceses. Esk-Omi Missions, Chalice, Development & Peace, Coady International Institute, and Society of St. Vincent de Paul are the popular missions that the members assist monetarily or with goods.
- The CWL Day of Prayer for Home Missions was very popular. Many indicated

they recited special prayers and rosaries. Some even had guest speakers and special activities.

- Report indicates all councils support some type of mission or charity (nationally or locally).

Lay Ministries

- Councils report that they have very active members in the church: lectors, eucharistic ministers, sacristans, altar servers, children's liturgy leaders, parish collection counters, hospitality, choir, cleaning, catechist facilitator, decorators, ushers, visitors to the sick and shut-ins.
- Many ministries are chaired or organized by our members.

Ecumenism and Interfaith Endeavours

- All dioceses took part in World Day of Prayer.
- On the whole, in most dioceses councils reached out to women of other denominations/faiths in the following ways: joint prayer services, invitations to meetings, sharing talks, guest speakers and social events.
- Many also promoted Fellowship of the Least Coin, Week of Prayer for Christian Unity, World Union of Catholic Women's Organisation (WUCWO), and Women's Inter-Church Council of Canada.

Chairperson's Activities Report

- Prepared prayers and prayer services for administration and-executive meetings, (and convention which were not used).
- Attended actual and virtual provincial executive meetings.
- Forwarded information received from national counterpart.
- Prepared and sent directives to diocesan counterparts.
- Submitted articles for the *ON-Line Newsletter*.

Recommendations

- Create a yearly calendar of events with topics of reflections –let's put on our thinking caps and make this a reality!
- Partner with a spiritual development chair from another council to share ideas and expertise.
- That the diocesan spiritual development chair offer training session for parish spiritual development chairs.

Recruit Members and Maintain Membership

- Councils recruited members, to reflect a wide cross-section of cultural and age diversity of the community. Personal invitations were the most effective means of recruitment. Also used were presentations at masses, bulletin boards, parish announcements, gift memberships, membership teas, and social media.
- New members had been recruited with a few being under the age of 40.
- The membership reflected the cultural diversity of the parish and general community.
- New members were engaged by: welcoming at meetings, conversations, invitations, new member kit, mentoring, sub-committee participation, orientation session, and phone calls.
- Current members were retained and former members attracted by showing the council's appreciation, through participation in decision-making for council activities, offering workshops and by inviting them to special events. Elderly members were kept informed of prayer requests, news, updates through email, postal, or drop off door service.
- Members were recognized with service pins, including the Maple Leaf, certificates of merit, luncheons, dinners, socials, and cards.
- The majority of councils used online membership and had an increase from the previous year.
- Almost all councils had an organization chairperson; however, a number of them were appointed rather than elected.

Leadership Development

- Members participated in the League Strategic Plan initiative as steering committee members, core leaders, leads and as committee members.
- The leadership course "Find Your Voice", which was recently developed by the Sault Ste. Marie Diocesan CWL Council, was shared with other diocesan councils.
- The diocesan organization and resolutions chairs attended a workshop in Toronto to introduce the revised Resolutions Supplement and a presentation of "Find Your Voice".
- Many members video-conferenced with League sisters across the province and across the country, making special connections with them.
- The Catholic Women's Leadership Foundation was promoted.
- Following much preparatory work, scheduled conventions, leadership courses, workshops and development days were cancelled due to the Covid-19 pandemic.
- The provincial presidents-elect developed an "Orientation Workshop" for presentation to all levels of the League.

League Resource Material

- Councils did encourage members to use manuals, to access the national, provincial and diocesan websites, and to read "The Canadian League" and newsletters.

Annual Reports

- The majority of councils did use the guidelines for completing annual reports and indicated that the reduced version reflected the activities of their committees.
- Annual reports were usually done in a group but due to restrictions of COVID most were done at home, independently.
- Organization chairs provided assistance to their executive to complete the reports, as needed.

Life Membership

- A few councils reported requesting assistance from honorary life and/or life members. Those that accessed their help found that they were a great benefit to their council.
- They provided a wealth of knowledge and acted as mentors by assisting in the completion of reports, ensuring that election protocol was followed and facilitating workshops.

Chairperson's Activities Report

- Attended and participated in executive meetings, in person and online.
- Prepared reports, newsletter articles, and directives.
- Distributed information regarding annual reports at all levels, collected diocesan annual reports and distributed them to the provincial executive.
- Compiled and edited the Annual Report Book for 2019.
- Since the Social Justice Award for 2020 could not be presented at convention, arranged to have the presentation made by Toronto Diocesan President Hilarion Mitchell to Miranda Pinto.
- Reviewed the 2020 applicants for the provincial Social Justice Award.
- At the Association of Catholic Bishops of Ontario (ACBO) online meeting, gave a presentation with the provincial president and submitted a report.
- In collaboration with the other provincial presidents-elect, developed an "Orientation Workshop" which will be offered to all levels of the League in 2021.
- Was as a member of the National Implementation Committee for the Strategic Plan, as "Lead" for "Sub-committee #1" tasked with revising the standing committees.

Recommendations

- That facilitators be chosen and trained to unveil the Orientation Workshop once Covid-19 restrictions are lifted.
- That every member keep informed about the Strategic Plan by regular visits to cwl.ca/to-inspire/ and cwl.ca/?s=strategic+plan where updates are made monthly.
- That councils and members familiarize themselves with the proposed changes to the Constitution and Bylaws and the proposed per capita increase.

Life Members across the Province

- One life member (LM) was our provincial president.
- Two honorary life members (HLM) served as parish presidents.
- Several LMs served at provincial and national levels as officers, sub-chairs, parliamentarians, screening officer, life member liaison (LML), keeper of the Book of Life and also the Chair of the Centenary Committee.
- Two LMs served on an *ad hoc* life membership committee. Because of Covid-19 all business was conducted by telephone.
- Many LMs became very creative attending virtual retreats, meetings and national webinars to keep informed and active in the League.
- Some LMs wrote letters to the government regarding Bill C-7, protecting the vulnerable in our society.
- Most LMs supported each other by prayer, phone calls, emails, cards, and when possible, with personal visits to the shut-ins and sick.
- Many LMs served as honour guards at funerals, Eucharistic ministers, cantors, sacristans, lectors, finance advisors, webmasters, money counters, and as members of their parish pastoral council and Society of St. Vincent de Paul.
- Few LMs were involved in fundraising events.
- Some LMs participated in the World Day of Prayer and the committee.
- One LM maintained the history cupboard for their diocesan CWL, updating the diocesan CWL archives.
- One LM prepared on a 100-year timeline, events of their diocesan CWL for their 100th Anniversary.
- One LM was on a committee to prepare the diocesan 100th anniversary prayer booklet.
- Two LMs planned the diocesan 100th CWL anniversary celebrations which were postponed due to Covid-19.

- One LM collected, prepared and submitted over 50 recipes from her parish.
- Two LMs organized and distributed a 100th anniversary diocesan cookbook.
- Some LMs prepared prayer services for parish and diocesan tree planting and dedication of 100th anniversary trees in recognition of the League's celebration of 100 years 1920-2020.
- One LM hosted members from the provincial council in her home who were in her diocese to host the workshop, "Find Your Voice".
- One LM created and presented a resolutions workshop for diocesan council presidents and resolution chairs in Toronto.
- Many LMs knit prayer shawls for the shut-ins and the sick, provided gifts for the sacraments, Christmas gifts for residents in nursing homes, providing items for the homeless shelters and missions, and prepared food for the homeless and needy as well as food baskets for those in need at Christmas time.

Life Member Liaison's Activity Report

- Forwarded the national life member liaison's (NLML) monthly communiqué to all diocesan life member liaisons (DLML), HLMs and the provincial executive.
- Forwarded requests for prayers, virtual prayer services, emails of interest to DLMLs for distribution to their LMs, HLMs, provincial executive, provincial presidents and the NLML.
- Cards, emails of support, congratulations, anniversary, thinking of you, get well and sympathy were sent to life members and/or their families.
- Christmas greetings were sent by email to all LMLs to forward to their LMs in their diocese. A Christmas card was mailed to LMs without an email address.
- A list of birthday celebrants was sent out every month to the DLMLs, provincial executive and the NLML with the date of their celebration and a request for prayers.
- A birthday wish was emailed to LMs with emails and a birthday card was mailed to those without an email address.
- Kept in touch with LMs without emails and reminded them to pray for the intentions of all members in the Catholic Women's League.
- Updated the Ontario Provincial Life Member Directory.
- Served on an *ad hoc* life membership committee for national.
- Prepared a welcome and introduction to the four new LMs for the *ON-Line Newsletter*.
- Updated the LM binders with new LMs and deceased LMs.

Recommendations

- That life members offer to mentor members; encourage them to take executive positions; then assist and support them.
- Life members, as role models, can initiate workshops, presentations and provide resources for the members in their parish and diocese. It is important that they remember their role as life member is to be accessible.
- Regrettably due to the pandemic, many councils did not host meetings. They were, however, kept informed of what was taking place at provincial and national levels through websites and webinars. When it is possible to do so, councils need to reach out to their life members to help build parish life. There will be a real need to bring back that sense of community to their parishes.

Christian Family Life Standing Committee Report 2020

Marriage and Family

- Councils offered encounter weekends for engaged and married, marriage prep, and programs family enrichment.
- Attended workshops on family life, and arranged events for Mothers'/Fathers' Day events, National Family Week and others related to the family.
- Several councils offered support to those suffering domestic abuse through collection of essential items, providing information on community services and demonstrating hand signal to signify abuse.

Sanctity of Life

- Councils were members of Euthanasia Prevention Coalition, Campaign Life Coalition, National Family Life, Priests for Life, Birthright and Right to Life as well as local organizations that help with family and pregnancy support services. Interestingly, Hearst-Moosonee Diocese does not have a registered charitable pro-life organization.
- Members attended March for Life, 40 Days for Life, pro-life vigils, Life Chain, pro-life walks; pro-life activities, and other events; hosted masses; wrote letters to and met with legislators; made pro-life brochures available in the parish; and all dioceses had parishes that prayed regularly for protection of life.
- Only a small number of councils sponsored or attended a presentation on Pope Paul II's "Theology of the Body."
- Several councils wrote to the Prime Minister and Minister of Justice urging legal protection for children before birth; educated members on the annual Sanctity of Human Life Day of prayer (January 22) and monitored the federal government's response to the resolution.

Ministry to Youth

- Members encouraged young people to participate in liturgical ministries; some offered instruction to youth in ministries.
- Supported children's liturgy, World Youth Day, leadership camps, Catholic Christian Outreach, National Evangelization Team (NET) ministries, summer camps, Girl Guides of Canada, youth conferences, Catholic Girl Leagues and other parish youth groups/programs.

Ministry to the Disabled

- Members encouraged/supported people with a disability to participate in liturgical celebrations. Some provided transportation and supported respite caregivers.
- Members provided communion, visits, cards of encouragement, transportation, and prayers.

Ministry to Seniors

- Members provided visits, communion, transportation, cards and calls of encouragement; and gifted memberships.
- Councils involved seniors in council events; organized special programs / celebrations; shared/served meals, invited retired women to join the League, and involved them in intercessory prayer.

Ministry to Widowed and Widowers

- Councils sent cards of condolences; arranged memorial services and funeral luncheons; visited and called; extended invitations to attend CWL and parish events; provided prayer and support after the death of a spouse.

Ministry to Separated & Divorced

- Some councils purchased "*Annulments Today-Merciful and Just*" pamphlets and/or participated in an information presentation; however, many councils gave little support to the separated and divorced or educate on annulment.

Vocations

- Councils promoted and prayed for religious vocations; watched YouTube video on the call to serve God through vocation to the ordained or religious life; sponsored discernment events for youth; adopted/supported seminarians; supported priestly retirement funds; hosted luncheons for priests and religious; gifted spiritual bouquets and cards; and encouraged inviting priests and religious into the home.

Chairperson's Report

- Attended and gave reports at winter and fall meetings.
- Prepared and sent directives and submitted newsletter articles.
- Began preparation of a toolkit on loneliness in response to pandemic.
- Encouraged diocesan chairpersons to reach out to members in new ways considering the isolation of the pandemic.
- Collated diocesan results and prepared annual report for provincial booklet.

Recommendations

- Promote engagement by councils in areas that lacked involvement in the past.
- Include at least one new project in each year's planning.
- As many members in this standing committee are repeating, long serving and tiring, identify a young council member with a passion for Sanctity of Life to mentor in this committee.

Communications Standing Committee Report 2020

The Canadian League Magazine

- *The Canadian League Magazine* was ranked excellent by the councils (85%).
- The councils considered it as a resourceful tool for advocacy and action.
- There were articles in each of the Winter, Spring and Fall editions that gave councils creative ideas to use at their meetings.

Media: for Evangelization

- Many councils (199) promoted faith-oriented programs, some councils supported (either financially, subscribed or donated) media to assist in their mission to evangelize like - The Catholic Register, Salt + Light TV, Mass for shut-ins; dailytvmass.com; Vision TV, ccb.ca, Catholic Herald and EWTN. Councils also mentioned in sharing information about on-line retreats, webinars, prayers services, workshops, and Pope Francis's message especially during the pandemic lockdown.
- Due to the pandemic last year councils could not invite media to their events.
- Councils (186) promoted World Communication Day (first Sunday in June). Councils (211) shared in mass on April 26, 2020 in honour of the feast of Our Lady of Good Counsel.

Media: to Promote the League

- Most of the councils (85%) used the national, provincial and diocesan CWL websites to keep themselves informed. Facebook (75%) and Twitter (60%) were also reported as being used to keep themselves well-informed.
- Councils (75%) used emails, newsletter to promote council's activities and events; majority published events on church bulletin and on their website (70%); some councils also used local newspaper to advertise. Telephone tree was being used by majority of the councils. Few councils (70) reported on having a budget for communications.

Media: Evaluation and Promotion of Good Content

- Councils (200) encouraged members to monitor media programs and inform providers of inappropriate content.
- Some councils (77) reported to media (Rogers) about adult content being too early in the day while children are watching and some reported cancelling of Netflix due to inappropriate content.

Media: Newsletter and Bulletins

- Councils (52%) distributed newsletter either via e-mail, church bulletin or on their website - majority produced it quarterly, some monthly and few published annually.
- Councils (80%) encouraged members to subscribe and promote Catholic newspaper, periodicals, and magazines.

Dignity and Rights of Persons

- Majority of councils are familiar with the Universal Declaration of Human Rights.
- Councils supported financially and/or through volunteer hours: street youth; and those suffering from homelessness, domestic violence, human trafficking, racism and poverty.
- Many councils reported making masks for frontline workers, first responders and nursing homes in their communities.
- Councils continued to educate themselves on the struggles facing Indigenous women by holding workshops and inviting guest speakers.

Social and Economic Justice

- The majority of councils encouraged their members to participate in the work of local organizations.
- Financial/volunteer/prayerful support was given to before and after school programs, drop-in centres, emergency shelters for the homeless, food banks, soup kitchens, domestic abuse shelters and violence prevention programs.
- The majority of councils reported supporting initiatives pertaining to affordable housing, employment and skills training programs and resource centers for single parents.
- Councils familiarized themselves with the restorative justice programs and prison ministry.
- One diocese reported donating to *Courage for Freedom Ontario* to help girls who have been victims of human trafficking.
- Councils held awareness and educational presentations on human trafficking.
- Overall, councils reported increased efforts made to keep in touch with members and to give assistance to shut-ins where ever needed.

Refugees, Immigration and Citizenship

- Councils reported honouring Remembrance Day by making donations to the poppy campaign.
- Members supported the Canadian troops by wearing red on Fridays.
- Members worked with their parishes to welcome immigrant families to their communities and acknowledged familiarity with the needs of immigrants.
- The majority of councils reported understanding the difference between a temporary foreign worker, immigrant and refugee.
- Councils continued to monitor Resolution 2016.01 *Equal Access to Permanent Resident Status* and kept their members informed on the amendments to the Immigration and Refugee Protections Act.

Canadian Catholic Organization for Development & Peace (CCODP)

- Many councils set up donations in their yearly budget for the Development and Peace 1% Program.
- Members attended Development and Peace workshops in their communities.

Developing Countries

- Councils reported continued and improved knowledge regarding conditions of child labour and the implications of trade laws and practices in the global economy.
- Councils participated in donating to the Pieta Bhavan India project through CNEWA to repair the well cover that was destroyed.
- Councils financially supported national and international organizations that focused on developing countries such as: *Chalice, Canadian Red Cross, Doctors Without Borders, Operation Eyesight International, Sleeping Children Around the World, Habitat for Humanity, Canadian Food for Children and Catholic Near East Welfare Association (CNEWA)*.

Chairperson's Report

- Attended winter and fall executive meetings in-person and virtually.
- Prepared and distributed directives.
- Submitted articles for the ON-Line newsletter.
- Forwarded communiqués from the national chairperson.
- Continued the C.A.R.E Connection project in response to the provincial theme on Loneliness. This was especially timely in light of the impact of the pandemic on communities.
- Kept in touch with diocesan community life chairpersons via email and teleconference call.
- Attended workshop on *Compassionate Community Care*.
- Collated diocesan results and prepared annual report for provincial booklet.

Recommendations

- Councils should study and become knowledgeable about the subheadings under this committee.
- Chairpersons should consider reaching out to other sister councils who may not have a chairperson for community life.
- Councils should continue to study resolutions and legislation relating to this committee and follow through on their action plans.
- Councils should encourage their members to educate themselves on issues pertaining to First Nations' people especially issues regarding youth and women.

Catholic Education

(i) Catholic Schools and Catechesis

- Majority of councils were aware of the quality and availability of Catholic religious instruction in their parishes and schools, and several councils actively encouraged parents to participate in Catholic education activities.
- Many councils were aware of the family life programs being taught.
- Majority of councils identified school needs with which they could assist (sacramental/faith development, providing New Testament Bibles, scholarships/bursaries, breakfast/lunch and after school/weekend food programs, winter clothing exchange, uniform items, hygiene products, supplies, Christmas baskets for families, extracurricular activities).
- Shoe boxes were filled with items and sent to Operation Christmas Child.
- Items were donated to women's shelters and long-term care residences.
- Members sewed children's masks and made shields for nursing staff.
- Members participated in Diocesan Rosary Prayer Program (monthly with students/teachers, daily rosary for safety of students during pandemic).
- Members made rosaries for students.
- One council donated to a diocesan campus ministries program.

(ii) Rites of Christian Initiation

- Members were involved in First Communion/Confirmation/RCIA programs.
- Online sacramental preparation programs were presented during the pandemic.
- Members participated as sponsors even when pandemic cancelled RCIA.

Literacy and Continuing Education

- Councils contributed to high school bursaries.
- A few councils encouraged members to help people improve literacy skills.
- A few councils had a list of Catholic universities/colleges in their area and promoted scholarships/bursaries for Catholic women to further their education.
- One council supported a parishioner's educational placement in Africa.
- One council collected school items, money for Literacy Nipissing Group.

Scholarships and Bursaries

- Majority of councils gave bursaries and scholarships to graduating Catholic elementary, high school, and university/college students.
- Several councils contributed to Coady International Institute, National Bursary Fund, Catholic Christian Outreach and National Evangelization Team (NET) Ministries of Canada.
- Council helped with expenses of a parishioner pursuing a religious vocation.

Wellness and Sickness/Disease

- Action was taken on resolutions 1997.06, 2001.01, 2007.03, 2008.03, 2011.03, 2011.04, 2014.02, 2015.02, 2016.02, and 2016.03.
- Letter-writing campaigns were initiated in opposition to Bill C-7 re Medical Assistance in Dying (MAiD).
- Several councils participated in, or donated to, Relay for Life.
- Members shared the link to register for national organ donations.
- One council focused on homelessness and human trafficking and made bags with personal hygiene items and took part in a walk to raise funds.
- Donations were made to Alzheimer Society, Autism Canada, Cancer Society, Children's Wish Foundation, Canadian National Institute for the Blind (CNIB), Diabetes Association, Mental Health Association, Euthanasia Prevention Coalition, Red Cross, Children's Treatment Centers, Heart and Stroke Foundation, Kidney Foundation, Multiple Sclerosis (MS) Society, MaterCare International, Ronald McDonald House, and pro-life initiatives.
- Councils supported Mental Health and Palliative Care postcard campaigns.
- Majority of councils participated in 12 Hours of Prayer for Palliative Care.
- Members donated blood through the *Partners for Life* program.
- During the pandemic, members regularly telephoned those living alone.

Environment

- Action was taken on resolutions 1990.07, 2001.04, 2004.07, 2005.06, 2015.03.
- World Water Day was recognized (donations to Water First Ontario, prayer service on water quality) as was Earth Day (reducing use of lighting, plastic/waste clean-up, Crayola Project, planting milkweed for butterflies).
- Several councils supported the *Care for Our Common Home* initiative.
- Members recycled paper/plastic; eliminated Styrofoam, plastic bags, and straws; used green organic waste bins; and collected milk bags to make mats.
- Trees were planted to commemorate the League's 100th anniversary.

Genetics

- Councils subscribed to Canadian Catholic Bioethics Institute newsletters.
- Members have a fairly good knowledge of advantages/disadvantages of technology to alter genes in light of the teachings of the Catholic Church.

Chairperson's Report

- Relayed information on *Bell Let's Talk Day*, National Bursary Fund, Coady International Institute, *Partners for Life* program, World Homeless Day, Earth Day, World Water Day, Fridays for Future, *12 Hours of Prayer*, Mental Health Week, Petition e-2807, Bill C-7, bullying, and spring cleaning for your health.
- Provided members with Canadian Catholic Bioethics Institute articles.
- Prepared reports, directives and newsletter submissions, attended virtual executive meetings, and forwarded updates from national chairperson.

Recommendations

- Provide information to members who wish to learn more about bioethics, genetics, the National Bursary Fund and new Alzheimer's research.
- Focus on leadership training for members to run for school trustee positions or political office (at all government levels).

Serve in a Consultative Capacity

Past presidents in Ontario:

- Approximately half (55%) participated in on-line meetings.
- Attended some actual meetings, indoor and outdoor.
- Majority (69%) were repeat past presidents.
- Prepared and collected election data for elections, facilitating parish elections and retaining info for deferred convention elections.
- Researched materials for significant council anniversaries and helped with relevant celebrations.
- Acted as mentors / providing advice when asked.
- Sought advice from a higher level when necessary.
- Many were over 65 years old who have been members for over 25 years.
- Felt their position was respected and appreciated (85%).

*Due to COVID restrictions most meetings were held on-line, if held at all.
Projects / fund raisers in the parish or community were on hold due to COVID.*

Be Responsible for Archives and History

To ensure the preservation of League history, historians:

- Maintained, reviewed and kept current the council's history / archives (30%).
- Due to COVID restrictions, visiting archives was restricted.
- Reported archived materials were kept indefinitely.
- Were aware of where the council charter was kept (95%).
- Reported materials such as minute books, important reports, photo albums, scrapbooks, CDs, memory sticks were kept in cool, secure, water-proof areas in the parish hall; the majority used acid-free covers, filing cabinets, totes.
- Kept lists of past executives with highlights from each term; kept list of pins and awards recipients.

Facilitate the Study and Implementation of the *Constitution & Bylaws 2013*

- High percentage of councils had copies of the *Constitutions and Bylaws 2013* (91%), policy and procedure manuals and other resources but rarely referred to them (20%).
- Encouraged regular visits to the national, provincial and diocesan websites.
- Assisted and encouraged the preparation and updates of parish manual of policy and procedure.

Other Activities

- Supported projects for national and provincial themes, focusing on homelessness and water conservation.
- Planned and supported on-line fund-raising events for a variety of purposes.

Historian's Activities Report

- Attended actual and on-line meetings.
- Completed reports and directives as required.
- Researched and submitted an article on "20 of the worst epidemics and pandemics in history" for the *ON-Line Newsletter*.
- Researched viable ways to keep archived materials, but unable to visit archives in Hamilton due to COVID restrictions.
- Collected items required to update archives.
- Collated diocesan past presidents' reports and prepared report for 2019 annual report booklet.

Recommendations

- Ask past presidents / historians as they are more than willing to assist when asked.
- Suggest ways you can keep members current with changes to C&B and policy and procedure. The majority of members rarely refer to these important documents.
- Offer support to president but allow and encourage the president to try her new ideas if they are within the policies of the League.
- As mentors, encourage and support your future leaders.
- Encourage councils to have a parish policy and procedure manual and up-to date history records.

Monitor and Study Legislation at All Levels of Government

- The large majority (95 to 100%) of those reporting, knew the names of their municipal, provincial and federal representative.
- Approximately 14% of councils reported accessing Hansard.
- On average, 80% received mailings from all levels of government.
- Approximately 40% of all councils in Ontario submitted a report to their diocese.

Council awareness of current issues:

- Bill C-7 Criminal Code Medical Assistance in Dying (MAiD)- about 80% councils were very aware.
- Bill C-13 Covid 19 Emergency Response Act – about 65% aware to very aware.
- Bill C-14 Covid Emergency Response Act, Number 2- about 65% aware to very aware.
- Bill C-15 The Canadian Emergency Student Benefit Act – about 50% aware to very aware.
- Bill C-71 Act to Amend Certain Acta and Regulations to Firearms – about 40% aware.

- Many bills were passed so quickly, there was insufficient time for proper research and action during Covid-19.

Research and Preparation of Resolutions and Briefs

- Topics of intent for a resolution included:

- In 2020 due to COVID 19 all diocesan and provincial conventions were canceled which resulted in no resolutions adopted at these levels. Resolutions prepared by parish councils for consideration and discussion have been deferred until the next convention. The resolution titles are:
 - Prohibition of E-Cigarettes with Cannabis
 - National Strategy to Address Loneliness
 - Promoting a Holistic Parish-Based Theology of the Body Lifestyle and Procreation Teachings

Study and Implementation of Resolutions Passed by Other Levels

- Topics studied and action taken on were:
 - long term care
 - Bill C7 Criminal Code Medical Assistance in Dying
 - legislate designation of hospice/palliative care services in facilities to
 - exclude medical assistance in dying
 - amend the Canada Health Act to identify palliative care as an insured service
 - child pornography
 - children's rights
 - homelessness
 - human trafficking
 - mental health, including the effects of abortion on mental health
 - spousal abuse
 - Lyme disease
- Seventy-five percent of all councils reported studying and implementing action plans on 2019 resolutions.
- One parish council mailed 322 signed letters to the Ontario Minister of Long-Term Care and Home Care regarding the health crisis of residents in long-term care.
- Approximately 700 members across Ontario sent letters to the Premier of

Ontario, Ontario Minister of Health and Ontario Minister of Long-Term Care and Home Care regarding the crisis of care in long term care homes.

Chairperson's Activities Report

- Submitted via mail to the Premier of Ontario, Ontario Minister of Health and Ontario Minister of Long-Term Care and Home Care, copies of 2019 adopted resolutions including briefs and cover letter from Ontario Provincial Council President Colleen Perry.
- Prepared directives, notices and reports as required by provincial guidelines.
- Submitted several articles for inclusion in the ON-Line Newsletter.
- Attended regular and virtual provincial council meetings.
- Fine-tuned power point on new resolution supplement from national council, and used it as resource material for resolution workshop.
- On February 6-8, 2020 presented resolution workshop for diocesan resolution chairs in Toronto. Twelve out of 13 dioceses were represented.
- Prepared resolutions for review, unfortunately conventions were cancelled and resolutions were deferred.
- Wrote letters to government officials re long-term care and medical assistance in dying (MAiD) and other current issues. Prepared sample letters; forwarded them to diocesan counterparts; encouraged members to write; and monitored their response to the request.

Recommendations

- Continue to create and distribute to councils and members, sample letters to assist in letter writing on resolutions to government representatives.
- Host workshops on resolutions.
- Invite government representatives to speak at parish meetings.
- Continue to communicate to members about resolutions at meetings, through emails, newsletters even though it is difficult to fill this position at the parish council level. Other standing chairs can educate members on resolutions that fall under their umbrella.

Activities Report

- Attended all Ontario Provincial Council (OPC) meetings.
- Prepared reports and summary reports for meetings.
- Prepared two directives.
- Prepared submissions to the monthly ON-Line Newsletter.
- Forwarded executive reports prior to OPC meetings.
- Prepared and sent correspondence as required/requested.
- Attended to OPC correspondence, including sympathy and get-well cards, congratulatory letters, thank you cards, thinking of you cards, anniversary certificates, and birthday certificates as directed by the provincial president.
- Mailed or emailed Christmas greetings to all arch/bishops in Ontario.
- Mailed or emailed Easter greetings to all arch/bishops in Ontario.
- Maintained and circulated updated committee lists for provincial officers, diocesan presidents, and spiritual advisors.
- Prepared binders for correspondence sent and correspondence received.
- Prepared and submitted annual report for *OPC Annual Report 2019*.

Annual Report Survey

- Five of the 10 councils reported having a corresponding secretary as a separate position.
- All councils made an extra effort to send out cards to keep in touch during this past year due to the pandemic.

Recommendations

- That workshops be developed to train secretaries, at all levels, in the use of social media to attend meetings and for distribution of news/information, as well as how to develop and maintain an electronic distribution list and to use electronic greeting cards.
- That corresponding secretaries have copies of *Good Gracious! - That all secretaries enlist the help of a competent proof-reader.

Parish and Diocesan Secretaries Reports (Summary)

- Received over 300 parish council reports from parish recording secretaries. Diocesan council recording secretaries reported that two councils received 100% of the requested reports. Four councils reported receiving less than 50% of the reports from parish recording secretaries.
- Served in a dual role as recording secretary and corresponding secretary in 1/3 of parish councils.
- Served as signing officer in 1/3 of the reporting parish councils.
- Elected to the position by parish councils in 1/3 of the reporting parish councils. More than 1/3 were appointed and some executive share the tasks at meetings.
- Reported that motion books were maintained in 1/3 of the parish councils.
- Maintained minutes and current lists of executive members.
- Served for more than one term previously as recording secretary for the parish council.

Recording Secretary's Activities Report

- Attended administration committee and executive meetings.
- Prepared and distributed the *Notices of Meetings*.
- Distributed minutes of previous meetings and agendas for the administrative and executive meetings.
- Prepared minutes of each executive meeting.
- Prepared notes of virtual meetings and administrative meetings.
- Recommended review committee members for each meeting to the president.
- Maintained an archive copy of the minutes of the Ontario Provincial Council and relevant reports.
- Recorded the roll call for each meeting.
- Maintained the motions book for the Ontario Provincial Council.
- Carried out responsibilities as a signing officer.
- Made submissions for the *ON-Line Newsletter*.

Recommendations

- Organize a binder or data stick containing the *Handbook for Secretaries*, relevant pages of the *Executive Handbook*, a role description, national and provincial resources and current directives as a resource over time for the recording secretary.
- Help structure the agenda and suggest timelines be listed.
- Review the role of the secretary and note details such as the role of signing officer and the knowledge of the location of the council charter as part of the role.
- Recognize and promote the value of a motion book as a record that is used to develop and amend the policy and procedures of the council.

- Of all the councils reporting, all of them had a treasurer.
- Some of the tools used were: bank statements, deposit books, cheque books, ledger/columnar books and/or computer program. Some used Excel spreadsheets, receipt books and disbursement books.
- Financial statements and account books were retained for five years.
- A minimum of two signatures were required on all cheques.
- Membership fees ranged from \$20 to \$30.
- The majority of the councils prepared a budget and had books examined or reviewed.
- Memberships were collected from November through March and some councils collected the bulk from April to August.
- Very little fundraising was done due to Covid-19.
- Councils were very generous in their donations even though Covid did have some impact on them.
- All 13 diocesan councils reported on their donations.

- Processed cheques, deposits and correspondence to acknowledge receipt of donations.
- Prepared directives, reports and newsletter article.
- Met with financial institutions to review guaranteed investment certificates (GICs).
- Prepared financial reports and membership reports for all executive meetings.
- Arranged accommodations and meals for the executive meeting and resolution workshop.
- Prepared books for the auditing firm.
- Reviewed, along with the administration committee, all applications for social justice award and development funds.
- Kept everyone apprised of the falling rates of interest affecting the council's investments.

- Plans for a spiritual retreat day in September were cancelled until 2021.
- We welcomed newly appointed Spiritual Advisor Fr. John Lemire, who will serve till 2023.
- Diocesan council held Zoom meetings in June and November to deal with business, with the understanding that all motions would have to be ratified at the next in-person meeting. The diocesan president participated in several conference calls and virtual meetings with OPC and the other diocesan presidents.
- Committee chairs continued to forward directives to parish counterparts in the hope that some work would still be able to be done, and to encourage and keep in touch with the members.
- A nomination for life membership was submitted.
- Donations were made to Toronto hosting council for the 2021 national convention, and to Catholic Near East Welfare Association Project for a drinking water well, in addition to all the regular donations made by parish councils.
- Parish councils were encouraged to hold 'safe' fundraising events, e.g., 'Bakeless Bake Sales'.
- Members participated in the national CWL Summer Speakers Series webinars in August.
- Some activities continued, i.e., collecting socks, hats, mitts and hygiene products and handmade facemasks for the needy, the homeless, and the lonely.
- The 'Care for our Common Home' water challenge resulted in saving more than 1773 gallons of water. Garbage was collected from yards and ditches. One council planted a tree.
- Councils kept in touch with fellow members via phone, email and newsletters.
- Timmins Diocesan CWL was featured in the October OPC newsletter with photos of various parish council activities.

- Eighty councils submitted at least one of the 12 annual reports for 2020.
- Development Day was held on February 22nd; the theme was *Building a New Culture: A Catholic Approach to Faith, Service and Justice* with 257 members present.
- Two new councils were organized: St. Rose of Lima, Scarborough Region on March 1st and St. Jerome's, Peel Region on March 4th.
- The COVID-19 pandemic declared on March 17th impacted the diocesan level and parish councils during the year. The Toronto 99th annual convention scheduled for April 30th and May 1st was cancelled. Executive and regional meetings were held using teleconference, virtual or a hybrid of both, which were the first use of these technologies for the council. Sixty-nine of the 84 councils in a survey on hosting meetings during the pandemic did not have in-person meetings but 49 held virtual meetings. An ad was placed in the June 28th issue of The Catholic Register to thank our pandemic heroes.
- Miranda Pinto, St. Barnabas Council, Scarborough Region, was the 2020 Ontario Provincial Council Social Justice Award recipient for her work with immigrants and refugees.
- The Toronto Diocesan Council hosted a virtual celebration on June 17th for the national 100th anniversary of the League. There were 60 councils, 230 members including Anne-Marie Gorman, National President. Members and families also planted 115 trees on September 19th at the Gore Meadows Community Centre grounds in Brampton for the anniversary.
- The diocesan council donated \$7,295 in lieu of usual in-person participation in events, scholarships and awards. Recipients were Martyrs' Shrine, Midland; the Cardinal's Dinner; Catholic Near East Welfare Association; Catholic Family Services of Toronto; Catholic Missions In Canada; St. Michael's Scholarship; Catholic Children's Aid Society Hope for Children Foundation Scholarship; Mary Dobell Pro-Life Awareness Essay and Poetry Literacy; Jean McCann Service Award for Youth; Mary Matthews Public Speaking Contest and Patricia Beattie Mentoring Award.
- Msgr. Pat celebrated a diocesan year-end mass on December 30th with 262 members present for the live streaming, followed by a virtual prayer service to mark inauguration of the year for St. Joseph.
