As summer days wind down and we enter into September, CWL councils begin to ramp up once again.

Congratulations to all who worked so diligently on the following two resolutions that were presented and adopted at the 76th Ontario Provincial Convention in July.

2023.01 *To Establish a Sustained Universal Intermittent Catheter Coverage* This resolution will be posted on the OPC website at <u>www.cwl.on.ca</u> under resolutions. Please review the Action Plan. This would be a great opportunity to add this activity to the *Faith into Action – Making a Difference* project.

2023.02 *To Add Compassionate Care to the National Temporary Voluntary Fund* This resolution was forwarded to the national council for their consideration at the national annual convention/meeting of members. Unfortunately, the national resolutions review committee did not recommend this resolution for presentation. However, the national committee did feel that the resolution has merit and encouraged the Ontario Provincial Council to bring the resolution back next year as a newly adopted resolution. We were also advised that National office will be updating the current criteria pertinent to the establishment of a national voluntary fund. Once finalized, this information would be updated in the National Policy and Procedure Manual.

At the 103rd National Meeting of Members, the national council adopted *Resolution* 2023.01 Combating Textile Waste in Canada. This resolution may be found on the national website, cwl.ca. More details will also be printed in the Fall Canadian League Magazine.
